All dogs must at least 3 months of age and be up-to-date with all shots.

Seminar fee includes complimentary donuts and coffee in the morning and a buffet lunch.

No dogs are permitted in the building. Please come prepared to crate or confine your dog during lecture periods. We suggest a “space blanket” to provide shade for your car or crate.

Harness, flags, and leads will be available for purchase.

There will be 3 follow-up sessions during the summer to assess your progress, answer your questions, assist you as you train your dog to track, and help you solve problems in specific areas that have come up in your training. There is no additional fee for these sessions! The sessions will be on April 15th (Sun), April 28th (Sat) and May 20nd (Sun)

Note: Auditor status is limited to the initial TED, follow-up sessions are not included.

Some of the materials for TED will be sent as files, prior to March 31st , to a special Yahoo Group that will be established for 2012 TED participants. You will be invited to join the group and will have to create a simple profile to do so. We will use this group to communicate with you and you will be able to ask questions. This group will be disbanded after the third follow-up session.

A receipt will be issued to confirm your entry. Directions, a checklist of things to bring and some introductory materials will be posted on the Yahoo group about a week before the seminar.
