# Tracklayer Certification

This training session will be devoted to certifying *members and potential members* to be tracklayers. All the tracks laid in our tests are by members who have been certified as tracklayers. Let John Etchells, and members who are already certified, take you through the process. AKC has made some changes in the Tracking rules, so please feel free to go through the tracklayer certification again so you are up-to-date.

*Bring a clipboard, pencils and a glove.  
Bring Your Lunch*

- Participants will be paired. "A" will plot a track, drawing a map and putting in flags at the turns. "B" will follow "A" and draw his/her own map. Then the roles will switch. Next each will re-walk their tracks, removing all flags except the two starting flags and place a marker at each turn, making sure it is not visible from even a few feet away. A glove will be left at the end.
- After all tracks have been plotted and re-walked, we will break for lunch. During the lunch break, copies of the Tracking Regulations will be distributed and an Open Book test will be given.
- Then each person will walk his track again and must return with the corner markers and glove, using his map as a guide.
- Each successful tracklayer will be considered a Certified Tracklayer and will be mailed a certificate attesting to that fact.

**Please call by Aug. 8 to let us know you are coming**

### Directions:

From the East: I-78 to Exit 17 (Route 31 North). \* Take Rt. 31 north - as you approach the second light, stay to the right as jug handle takes you off onto Route 513 at the 513 - Grayrock Shopping Center - at the STOP sign turn right and note mileage at this point. Follow Rt. 513 to and through High Bridge. Shortly past Voorhees High School, turn left onto Rt. 628. There is an old, unopened Sunoco gas station on the corner. This turn will be 3.9 miles from the light on Rt. 31. Follow Rt. 628 to full stop at Hill Rd. Turn left. Watch for brick buildings on the left - first a firehouse, then the Municipal Building, then the First Aid Squad. (Total mileage from light on Rt. 31 is 5.7 miles). Park in the rear of the buildings.

From the West: I-78 to Exit 15. Right at end of ramp. Take Main Street into the town of Clinton. At the light in the center of town, turn left onto Halstead Street (Route 513). Observe the speed limit here! Halstead will end at Route 31 where you turnleft and will be at the first light. Follow directions above from \*



## New TD

Ch. Chesabar Sandra Kodiak WD, CDX, TD, CGC, TDI (Ch. Chesabar's Sea-J x Ch. Winfield's WAC of Homespun) bred by Patsy and Rudy Barber Jr.

Kodi is owned, trained and counter surfs with James Friedl. She earned her TD on her first attempt this past May 6<sup>th</sup> at the Tracking Club of Massachusetts event held in Topsfield, Mass, on the outskirts of Boston.

To my discomfort I drew the fifth and last track from the lottery that morning which added to the tension of the day along with the approaching heat. Although, I was happy not to have received the course with the start flags situated parallel to the river. No doubt my fuzz butted brown waterdog would have insisted on a swim thus adding to the moment, she's a magnet and an annoying whiner for the water. When our turn came after watching the success of three out of four participants pass, I felt her excitement as she told me to 'hurry lets go' while doing the Bouncing Bronco Dance as I put on her harness. I walked up to the start where we were greeted by judge Mary Thompson.

I gulped as I viewed the course ahead of us with its steep hills and valleys of which we have never really trained on. This day in May was beautiful not as hot as it was the previous week with unseasonably high 90+ degrees instead it was slightly overcast with traces of sun, cool and comfortable, perfect for tracking. With a fair amount of wind to cause concern, however, Kodi's start at the flag was unlike her usual gallop and sprint, short cut off a few turns (to annoy her handler), direct-to-the-glove routine. This course was full of challenges from the beginning as she walked past the starting flags on top of the first hill, with her nose up.

I encouraged her to work and said 'lets go find the glove' as we went downhill on the first leg. Thinking to myself "oh no, she's not concentrating, what's distracting her so soon"! When she got through this unknown airborne distraction she tracked into a valley just below the start flags. She finally put her nose down to work and found herself in some fragrant ground cover and some dry dead grass that caused her to snort and sniff and work hard to find the track. She paused occasionally to look at me but all I could do was hope that she'd move onward to the next hill and out of this over scented valley, before hearing the whistle which would send us to a long Ferry ride home. I continued encouraging her to work through this cover and to find the glove. I gave her a loose line figuring that if she tracks out of this valley than maybe at the approaching hill with it's better grass, she'll get her confidence and stay on track.



After what seemed like an hour, but no more than minutes, Kodi discovered her way through this fragrant cover and started up the hill on the other side of the valley with this first leg being 115 yards long to the first turn at some dandelions. Her tail started doing the happy wag, she looked back at me as to say "I got it now dad - just don't trip - hold on and enjoy the scenery." She worked methodically at the first turn a left that transverses the steep hill, keeping her nose down only to circle and check the scent at the corner to assure herself of the correct direction. Her pace picked up for the next seventy-five yards and we were now off and running with a taught line and whole lot more confidence. I was now concerned about over shooting the next turn which was fast approaching. The second turn was a right and she quickly rechecked herself and now we were faced with the steepest and the mother of all tracking hills. Together we scaled the 110-yard hill and at the top she located the third turn - a right in the gusty wind and she cornered it nicely. The pace continued to quicken along top of the hill and we were off and running again to a quick left turn at fifty-five yards next to some tire tracks the fourth and final turn. It was now evident with a great adrenalin rush (hers and mine) that the grand prize was in reach and waiting for us at the bottom of the hill. Without hesitation she scooped up the old glove in stride, did a big circle and "Roo Rooed" for the judge, tracklayer and gallery. Kodi, who will be 10 on July 18<sup>th</sup> is unaccustomed to working and climbing on steep hills as we had to do to during this 480 yd track. She completed it nonetheless, and qualified for her TD in nine minutes. Kodiak enjoys this sport immensely, and will continue to work at the next level.

I was fortunate enough to get into the AKC Australian Shepherd Tracking at the Nationals. I was even luckier to draw the first track.

It rained the morning I drove from the motel near Woodstock Conn to Gardner Mass where the tracking site was. I remember looking at the side of the road and seeing sand and thinking, "did I practice in sand?"

It was foggy and very wet and Lacey's nose was on the ground the whole time I was getting her ready to start her track. In fact, she tracked from the van, 1500 feet through the woods and to the start flag of her track.

She then did her usual grass eating between the two flags. If nothing else I guess I have learned patience.

All of a sudden she was off. Trotting and pulling, left turn and down hill, right turn and down hill, right turn and up hill, and then she went a distance of very long leg and stood there.

I was thinking she passed glove and was encouraging her to get it. She was looking over her shoulder back at me which she has done in the past when she overshot a turn.

She turned sharply and charged down the very steep hill. We went forever. She was still flying down the hill when she dove her head under herself and plucked up the glove and made a U turn and galloped back up the incline to make the delivery. She was so proud of herself and she wasn't going to give up the glove.

I am so glad she qualified that day. I don't think I could have physically made it out of that field if she didn't. It was gigantic huge hillside. All the way out it was uphill. In fact, it took longer to get out of the field than to run the track.

The judges, AKC Rep, and tracklayers were all full of praise and ecstatic. "She has a beautiful tracking style" "A pleasure to watch."

Lacey is the first Australian Shepherd to earn her TD at an AKC nationals. . I am very, very proud.

The Lenape Tracking Club 2001 Tracking Test will be dedicated to the memory of Janet Horn and Priscilla White.

### HELP WANTED
